#### The Power of "I Do"

Are you in a 401k plan? Are you married? If so, your spouse carries an outstanding "protection plan." Federal law states that every cent in your 401k goes directly to your spouse upon your death despite what your beneficiary form or will states.

If you prefer to name a different beneficiary, your spouse must sign a waiver and have this written disclaimer filed with your plan. For example, should you want to leave the proceeds to your children from a previous marriage, you can ask your spouse to waive his/her rights.

Warning: If you are separated or divorced, only the ex-spouse can waive their rights. Even if you have had a 'significant other' for many years, your ex-spouse will have total legal claim to your 401k unless s/he has signed a waiver. (www.401khelpcenter.com)

Remember, only a spouse can waive these rights! It cannot be done in advance of a wedding. Put a 'promise-tosign' statement in your prenuptial agreement if you have one.

### **IRA Beneficiary**

Are you wondering who will get your IRA proceeds when you pass on? It will be the person you named on your IRA beneficiary form. If you named your spouse but later remarry and name your new spouse in your will as heir yet you did not remove your previous spouse from your IRA, your ex will receive the money. Even if the divorce

decree states otherwise, your ex is the beneficiary until it is changed on the IRA. Don't accidentally disinherit your spouse. Clean up your beneficiary forms right away!

## Variable Annuity with Lifetime Benefits

Couples quite often don't realize that the annuity they purchased to use as a retirement/insurance vehicle may cut the surviving spouse out. Usually these variable annuities with lifetime benefits combine a type of investment with a guaranteed lifetime income. Unfortunately, many provide spousal benefits to cover only the current investment value of the annuity or perhaps offer a death payout. If you want to be sure that your annuity covers both you and your spouse, you will most likely have to pay more or settle for a lower guaranteed income.

The economic environment of the last few years has triggered a dramatic change within insurance companies issuing such annuities. With low interest rates and market volatility, insurers have radically decreased the benefits and features by raising the cost, lowering guarantees, enforcing new restrictions, or even eliminating them all completely.

These are complex contracts. If you have ventured into this realm, you should examine your product to be sure you understand what you are holding.

#### Wild Walmart Facts

- Walmart has more employees worldwide 2.2 million than the population of Houston. The mega-retailer employs
   1.4 million people in the U.S. alone.
- In fiscal year 2012, Walmart registered approximately \$444 billion in sales, which is \$20 billion more than Austria's GDP. If Walmart were a country, it would be the 26th largest economy in the world.
- If Walmart were an army, it would have the second largest military in the world, behind China.
- Walmart is bigger than Home Depot, Kroger, Target, Sears, Costco, and K-Mart combined.
- If Walmart's more than 900 million square feet of retail space were spread out over one place it would take up roughly 34 square miles, which is about 1.5 times the size of Manhattan.

- In 2000, Walmart was sued 4,851 times, or about once every two hours.
- 90 percent of all Americans live within 15 miles of a Walmart.
